MPORTANT: Do not expose children, pets or other non-target animals to rodenticides. To help prevent accidents:

1. Store product not in use, in a location out of reach of children and pets. 2. Apply bait in locations out of reach of children, pets, domestic animals and non-target wildlife or in "tamper-resistant" bait stations. These stations must be resistant to destruction by dogs and by children under six years of age and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hoofed livestock, raccoons, bears or other potentially destructive animals or in areas prone to vandalism.

3. Dispose of product container and unused, spoiled and unconsumed bait as specified on this label.

Note: Bait stations are mandatory for outdoor, above-ground use. Tamper-resistant bait stations must be used if children, pets, non-target mammals or birds may access the bait.

#### USE RESTRICTIONS

This product can only be used to control Norway rats, roof rats and house mice in and within 100 feet of man-made structures constructed in a manner so as to be vulnerable to commensal rodent invasions and/or to harboring or attracting rodent infestations. Examples of such structures include homes and other permanent or temporary residences, food processing facilities, industrial and commercial buildings, trash receptacles, agricultural and public buildings, transport vehicles (ships, trains, aircraft), docks and port of terminal buildings and related structures around and associated with these sites. Fence and perimeter baiting, beyond 100 feet from a structure as defined above, is prohibited. Do not place near or inside ventilation duct openings. This product must not be applied directly to food or feed crops. Do not contaminate water, food, feedstuffs, food or feed handling equipment or milk or meat handling equipment or surfaces that come into direct contact with food. When used in USDA-inspected facilities, this product must be applied in tamper-resistant bait stations. Do not broadcast bait. Do not use in sewers. Burrow baiting with this product is prohibited.

Do not sell this product in individual containers holding less than 4 pounds of bait.

# SELECTION OF TREATMENT AREAS

Determine areas where rats or mice will most likely find and consume the bait. Generally, these are along walls, by gnawed openings, beside burrows, in corners and concealed places, between floors and walls or in locations where signs of rodents have been seen. Protect bait from rain or snow. Remove as much foodstuff as possible from the area to be baited.

#### APPLICATION DIRECTIONS

Rats: Apply 2 to 8, two-ounce blocks (4 to 16 ounces) per placement. Space placements at intervals of 15 to 30 feet in infested areas. Maintain an uninterrupted supply of fresh bait for at least 10 days or until resh signs of rat activity cease to appear.

Mice: While wearing waterproof gloves, break each 2 oz. block into 3 pieces and place 1 or 2 pieces at 8 to 10 foot intervals. Larger placements (up to 3 pieces (2 oz.)) may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until fresh signs of mouse activity cease to appear. Follow-up: Replace contaminated or spoiled bait Immediately. Wearing waterproof gloves, collect and dispose of all dead animals and leftover bait properly. To discourage reinfestation, limit sources of rodent food, water and harborages as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations. Regularly check the stations and bait as needed.

STORAGE AND DISPOSAL

DO NOT CONTAMINATE WATER. FOOD OR FEED BY STORAGE OR DISPOSAL.

PESTICICE STORAGE. Store only in original container in a cool, dry place inaccessible to children and pets. Keep containers closed and away from other chemicals.
